



MADRID DECLARATION

We, representatives of the European Association of Credit Rating Agencies („EACRA“) and the Association of Credit Rating Agencies in Asia („ACRAA“), through our respective Board of Directors, assembled in a historic first joint conference on April 16th, 2015 in Madrid, Spain,

Recognizing the critical role of Credit Rating Agencies in providing competent, objective and independent credit opinion to the financial markets for informed investment decisions; and

Acknowledging the special responsibilities attached to that role,

Do hereby declare

That we shall pursue our tasks applying the highest standards of professional and ethical conduct;

That we shall perform our functions in conformity with the highest norms of transparency, accountability and fairness;

That we shall continually explore areas of collaboration through which we can promote the sharing of knowledge, skills and competencies to enhance the credit rating discipline, to serve the interests of all participants in the financial markets worldwide; and

That we shall seek to cooperate with regulators to establish and maintain a progressive regulatory environment that promotes an orderly growth of financial markets and the adequate protection of investors.
